I, the parent/legal guardian of the above named child, who is a candidate for a position on a NFL FLAG FOOTBALL team, hereby give my permission for his/her participation in any and all of the activities of the NFL FLAG FOOTBALL League during the current season. I recognize and acknowledge that there are certain risks of physical injury (including but not limited to concussions and other head injuries, sudden cardiac arrest or death) to participants in this program/activity, including transportation to and from activities. I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity (which includes transportation connected with participating in the NFL FLAG FOOTBALL League). I do further hereby release, absolve, indemnify, and hold harmless the NFL FLAG FOOTBALL League, the City of Othello, Othello School District, Adams County, and their organizers, sponsors, supervisors, officers, agents, servants, volunteers and/or employees.

In case of injury to my child, I hereby waive all claims against the organizers, sponsors, or any of their supervisors, officers, agents, servants, volunteers and/or employees. I likewise release from responsibility any person transporting my child to and from the activities.

I will furnish the certified birth certificate of the above named candidate upon request of League officials. I certify that the information I provide is correct to the best of my knowledge and I am aware that any deliberately falsified information would disqualify the above named candidate from participation in the League.

I do hereby fully release and forever discharge the NFL FLAG FOOTBALL League and the City of Othello from any and all claims for injuries, damages, or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with this program/activity.

I further grant the Released Parties the right to photograph, and/or videotape me or my said child and further to display and/or use my said child's name, likeness, and appearance, in all media and in all forms including photographs and digitized images, whether for advertising, publicity, or promotional purposes.
