I hereby certify that on the 28<sup>th</sup> day of March A. D. 1883. I made a survey of two Additions to the Village of Magnetic Springs and laid out into town lots for James C. Brown and Robert Hedding the following described premises. Beginning part of O. U. M. Survey N<sup>o</sup>. 3696 and Commencing at a stake in the north margin of Fountain avenue near an angle in said avenue, Thence N 33 E 1/2 poles to a stake. thence N 57 W. 54.54 Poles to a stake. Thence S 33 W. 12.12 Poles to a stake in the margin of said avenue. Thence S 57 E. 54.54 Poles with said avenue to the Place of Beginning. Containing 4 7/10 acres of land to be the same more or less. and to be known as Brown's Addition.

Also a piece of land commencing at a stone in the center of the Pharisburg and Delaware Gravel Road, and on the west margin of said Fountain avenue. Thence with the west margin of said avenue N 1/4 E 107.74 poles to a stone southeast corner to Lot N<sup>o</sup>. 157. Thence N 38 W. 8.6 Poles to a stone northeast corner to lot N<sup>o</sup>. 151. Thence N 17 W. 12.60 Poles to a stone Northeast corner to lot N<sup>o</sup>. 150. Thence with the south margin of said Fountain avenue N 59 W 24.84 Poles to a Stone in the center of a street and the South margin of said avenue. Thence with the center of said street S 1/4 W. 118.37 Poles to a stone in the center of said Pharisburg and Delaware Gr. Rd. Thence with the center of said Road. S 52 1/2 E. 37.23 Poles to the beginning. Containing 22 1/10 acres.

Said Fountain ave. also contains 5 2/10 acres. making in all 28 acres of land more or less and to be known as Heddings addition to the town of Magnetic Springs.

For further description reference is hereby made to the adjoining plat which is a correct representation of said Addition.
