now attached to the Village of Milford Center in said County, That he has ob-
tained the assent of the council of said Village to be detached therefrom said land.
The assent is given by legal ordinance duly passed and published, a true copy of
which is herewith filed as is also an accurate map of that portion of
land, sought to be detached, said land sought to be detached and described
as follows:- Situate in Union Township Union County Alio. Beginning
at a stake at the north west corner of said corporation and in the south
side of the Milford and North Darby Gravel Road. thence with the North line
of said Road. S 71° E 73 1/2 poles to a stake. thence S 19 W. about 60 poles to the
North side of the Mill Road thence up the North side of said Road to the
west line of said corporation. thence with said line N 16° E 81 poles to the
Beginning, containing Thirty two acres.

The said Samuel Buffington prays your honorable body to detach
said land from the said Village and attach it to the contiguous terri-
tory of Union Township.

To Detached Territory

Be it ordained by the Council of the Village of Mil-
ford Center Union County Alio, Sect. 1. - that the
assent of said council be and the same is hereby given
to detach from the corporation of said Village the fol-
lowing Territory to wit:

Beginning at a stake at the North west corner of said corporation
and in the south side of the Milford and North Darby Gravel Road.
Thence with the north line of said corporation and South side of said
Road. S 71° E 73 1/2 poles to a stake. thence S 19 W. about 60 poles to the north
side of the Mill Race. Thence up the north side of said Race to the west
line of said corporation, thence with said line N 16° E 81 poles to the be-
ginning.

Sec. 2. This Ordinance shall take effect and be in force from and
after its legal Publication.

Commissioners of Union County met in session
at the Auditors Office.

In the matter of the detachment of territory from the incorporated Village of Milford } Samuel Buffington this day filed a petition with the Board of Commissioners praying that certain lands of which he was the exclusive owner be detached from the incorporated village of Milford Center Ohio. He also filed at the same time an accurate map or plat of the territory described in said petition and the council of said incorporated village having assented to the detaching of said territory as prayed for by an ordinance duly passed by said council on the 23^d day of Feb. 1883. a certified copy of said ordinance being filed with said petition and the Board having this day met to consider this matter thereupon the cause came on to be heard on said petition and the map and plat of the territory and ordinance duly filed.

After a careful hearing of said petition and examination of all papers on file pertaining thereto, it is ordered by the Board that said territory described in said petition and said plat be and the same is hereby detached from the incorporated limits of said Village of Milford Center Ohio and said territory is hereby attached to the Township of Union and shall hereafter be contained in the limits of said Township of Union and the prayer of said petitioner is fully granted.
