Sealed proposals will be received by the Board of Commissioners of Union County, Ohio for the following:

2015 UNION COUNTY PAVEMENT MARKING PROGRAM

Specifications and Bid Forms are available in the office of the Union County Engineer, 233 West Sixth Street, Marysville, Ohio 43040 between the hours of 7:30 am and 5:00 pm on weekdays, (holidays excluded).

This notice can be obtained through the County Engineer's website (www.co.union.oh.us/engineer) under the "Current Bid Information" section.

Proposals must be received by 11:00 A.M. on Tuesday, July 28, 2015, the Office of the Board of Commissioners of Union County located in the County Office Building, 233 West Sixth Street, Marysville, Ohio 43040. The proposals will be opened and read aloud immediately thereafter.

Each bidder is required to furnish with its proposal a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The owner intends and requires that this project be completed no later than October 2, 2015.

Union County's BASE Bid estimate is \$67,000.

Union County's ALTERNATE Bid estimate is \$72,000.

Bidders must comply with the prevailing wage rates on Public Improvements in Union County, Ohio as determined by the Ohio Department of Commerce Division of Industrial Compliance and Labor, Bureau of Wage and Hour, (614) 644-2239.

Proposals will be accepted only from contractors who are pre-qualified with the Ohio Department of Transportation. Pre-qualification status must be in force at the time of bid, at the time of award, and through the life of the construction contract.

Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and the Governor's Executive Order 84-9 shall be required.

The Board of Commissioners of Union County reserves the right to reject any or all bids, or to increase or decrease or omit any item or items, or to waive any informalities in any bid(s), and to award the contract to the lowest and best bidder in accordance with Section 307.86 of the Ohio Revised Code as determined by the Board of Commissioners of Union County.
