7 AMENDING ORDINANCE REGULATING PARKING AND  
8 ESTABLISHING ENFORCEMENT PROCEDURES; **AMENDING**  
9 **ORDINANCE NO. 2005-535**

10  
11 WHEREAS, the City Council of the City of Keizer has adopted Ordinance No.

12 2005-535;

13 WHEREAS, such Ordinance sets forth regulations for parking;

14 WHEREAS, the Council finds that it is appropriate to revise the fees for violation  
15 of the Ordinance;

16 WHEREAS, the Council finds that it is appropriate to apply the parking  
17 regulations to private streets as well as public streets;

18 WHEREAS, traffic laws with few exceptions do not apply on private streets;

19 WHEREAS, the City of Keizer, under general police powers, desires to apply  
20 State traffic laws on private streets to provide for the safety of its citizens;

21 WHEREAS, the City of Keizer desires to adopt the Oregon Vehicle Code for  
22 enforcement of parking regulations on private streets;

23 WHEREAS, the Council finds that it is appropriate to amend Ordinance No.  
24 2005-535;

25 NOW, THEREFORE,

1 The City of Keizer ordains as follows:

2 Section 1. AMENDMENT OF SECTION 1(d) OF ORDINANCE NO. 2005-

3 535. Section 1(d) of Ordinance No. 2005-535 is hereby amended as follows:

4 (d) Motor Truck: A “motor truck” means a vehicle defined by  
5 ORS 801.355 that has a gross vehicle weight rating of more than 12,000  
6 pounds.

7 Section 2. AMENDMENT OF SECTION 1(g) OF ORDINANCE NO. 2005-

8 535. Section 1(g) of Ordinance No. 2005-535 is hereby amended as follows:

9 (g) Recreational Vehicle: A “Recreational Vehicle” means a  
10 vehicle defined by ORS 801.409.

11 Section 3. AMENDMENT OF SECTION 1 OF ORDINANCE NO. 2005-535.

12 Section 1 of Ordinance No. 2005-535 is hereby amended by the addition of the  
13 following:

14 (m) Oregon Vehicle Code: Oregon Vehicle Code are those laws  
15 set forth in ORS Chapters 801 through 826, as now enacted or later  
16 amended. Such Code is adopted in this Ordinance by this reference as if  
17 fully set forth.

18 Section 4. AMENDMENT OF SECTION 1 OF ORDINANCE NO. 2005-535.

19 Section 1 of Ordinance No. 2005-535 is hereby amended by the addition of the  
20 following:

1 (n) Highway: A “highway” means every public way, road, street,  
2 thoroughfare and place as defined by ORS 801.305 and all private streets  
3 within the City limits of the City of Keizer.

4 Section 5. AMENDMENT OF SECTION 15 OF ORDINANCE NO. 2005-  
5 535. Section 15 of Ordinance No. 2005-535 is hereby amended as follows:


6 SECTION 15. VIOLATIONS. Violation of this Ordinance is an  
7 infraction punishable by a fine of \$500.00.

8 Section 6. EFFECTIVE DATE. This Ordinance shall take effect thirty (30)  
9 days after its passage.
