The Board reviewed the following:

- **3.** A letter from the South Central Community Action Partnership Re: funds from the Emergency Shelter Grant Program.

#### **BID OPENING**

The Board opened and reviewed the bid received for the MCCJC Pharmaceutical RFB, which was not in the correct format. The MCCJC will review the bid and specifications and will make a recommendation to the Board of County Commissioners through the County Administrator.

### LOCAL LAW ENFORCEMENT BLOCK GRANT PUBLIC HEARING

The public hearing for expenditure of funds provided by the Local Law Enforcement Block Grant for the 2003 grant years was held on June 14, 2004, at 9:15 a.m., before the Board of County Commissioners at the Cassia County Courthouse in Burley, Idaho. The purpose of the meeting was to receive public input and recommendations on how to apply the funds provided by the grants. Those in attendance were the Board of County Commissioners, representatives of the Sheriff's Office, a representative of the Prosecuting Attorney's Office, the local school district officials, media representatives and private citizens. Under Sheriff Cary Bristol reviewed the use of block grant funds for law enforcement throughout the County. The consensus of those present was that funds will be utilized to augment regular patrol activities, including special emphasis patrols for crime fighting and to show presence at school related functions. It was also discussed that funds would assist in providing extra, temporary coverage for the Mini-Cassia Drug Task force. It was moved and seconded to approve the use of these block grant funds for such stated purposes by local law enforcement and voting in favor of the motion was unanimous by the Board.

#### **REVIEW AGREEMENTS**

The Board reviewed an agreement with the Boy Scouts of America to conduct the Scout-a-Rama at the Fairgrounds from June 15, 2004 through June 19<sup>th</sup>, 2004 and the agreement to conduct the "Paint Horse Show" sponsored by John Gerrard on June 19<sup>th</sup>, 2004. It was moved and seconded to sign both of the agreements and voting was unanimous by the Board.

The Board reviewed Resolution #2004-06-1, a Resolution Designating Emergency Interim Successors and Specifying the Order of Succession for the Board of Commissioners for Cassia County, Idaho. It was moved and seconded to sign the resolution and voting was unanimous by the Board.

The Board reviewed grant number 04-BY-59-TF-4C-00-3 for \$113,956.00 for the Drug Task

Force Grant, as presented by Randy Kidd, head of the Drug Task Force. It was moved and seconded to sign the grant application and voting was unanimous by the Board. Randy Kidd then explained that as the County share increases, the sale of "seized property" would help to offset the cost to the County

# **CHANGE OF STATUS**

The Board reviewed three change of status forms for the Sheriff's Office. It was moved and seconded to approve the changes of status and voting was unanimous by the Board.

#### LOCAL PURCHASES

Commissioner Handy led a discussion concerning making local purchase a priority for all County Departments. Since taxpayer dollars are used to make purchases, we should extend all efforts possible to expend the dollars within Cassia County.
