PREVIOUS WEEKS= MINUTES

CORRESPONDENCE

The Board reviewed the following:

- 1. A letter from Simplot Inc of Heyburn, Idaho giving the Board formal notice of the upcoming job eliminations and plant closure of the Heyburn Plant. The Company will cease operations on or about November 1, 2003.
- **2.** A letter from the City of Rocks National Reserve concerning the City of Rocks Fire Management plan.

LAW ENFORCEMENT

The Board discussed the law enforcement contract the County has with the City of Burley. The new ISTARS program will likely reduce the disbursement of monies to the City, which may impact the contract.

BUDGET HEARING

Chairman Crane led the discussion with the Department Heads concerning the Fiscal Year (FY) 2004 County Budget. All Department Heads explained their proposed budgets and expressed thanks to the Board and the Auditor's office for assistance in preparing their budgets. Chairman Crane recessed the Public Hearing and the Board will reconvene on Thursday, September 4, 2003 at 11:00 a.m. to further discuss the pending budget. The Board will then finalize and sign the final budget on Monday, September 8, 2003.

SHERIFF'S PATROL CAR QUOTES

Captain Carey Bristol discussed quotes from local automobile dealers for a new patrol car for the Sheriff's Department. It was moved and seconded to accept the quote and purchase a new patrol car from Goode Motor of Burley, Idaho for a total cost of \$23,535,00.

JUNKYARD MATTERS

Kerry McMurray discussed the junkyard matters in the County and the need to have the Junkyard Committee serve an active role in resolving the junkyard complaints in Cassia County.

CHANGE OF STATUS

It was moved and seconded to approve the hiring of one (1) new full-time employee for the MCCJC and voting was unanimous by the Board.

COUNTY BUILDING MATTERS

The Board discussed installing a rain gutter on the Casa Bonita apartment and some of the keys having problems unlocking the rear door of the Courthouse. The decision was to install the necessary rain gutter, wait until the Assessor's office moves to the Annex building and then rekey the entrance doors or have new keys made

CITY OF ROCKS

The Board reviewed a letter from Wallace F. Keck, Park Manager of the City of Rocks regarding an Agreement on equipment usage. It was moved and seconded to enter into the Agreement to transfer full ownership of a Caterpillar tractor D7F and a 1985 Mack 10-wheel dump truck to Cassia County and voting was unanimous by the Board.
