

NOTICE OF HEARING

NOTICE is hereby given, pursuant to Idaho Code Section 63-1311A, that the Board of Commissioners for Cassia County, Idaho will hold a public hearing on Monday, August 14, 2017 at 9:15 a.m., or as soon thereafter as the matter can be heard in the Commission Chambers, Old Cassia County Courthouse, Room #206, 1459 Overland Avenue, Burley, Idaho to receive comments and to explain reasons for actions on the proposed Sheriff's fees increases for Cassia County.

The current type of services, rates and proposed increased fees are as follows:

For serving a subpoena for each witness summoned	\$30.00	\$20.00
For commissions for receiving and paying over money on execution or other process when land or personal property has been levied on and sold:		
On the first \$1,000.00	3%	2.5%
On all sums above that amount	2%	1.5%
But in no case of sale of real estate shall his commission exceed the sum of	\$100.00	

When the amount of such sale is credited on the debt and no money is transferred	\$100.00	\$100.00
For commissions for receiving and paying over money on execution without levy, or where land or goods are not sold...		
On the first \$1,000.00	1.5%	2.5%

For drawing and executing a sheriff's deed	\$20.00	\$20.00
For executing a certificate of sale, exclusive of the filing and recording of same	\$20.00	\$20.00

For traveling to serve any summons and complaint, or any other process by which an action or proceeding is commenced, notice, rule, order, subpoena, venire, attachment on property, to levy and execution, to post notice of sale, to sell property under execution or other order of sale, or execute an order of arrest, or order for the delivery of personal property, writ of possession or restitution, to hold inquest or trial or right of property, for each mile actually and necessarily traveled for the first twenty-five miles no charge shall be allowed, and for any miles traveled over twenty-five miles, even if process is not served, the following shall be allowed, in going only	\$0.60	
For copy of and making an interim return on a continuing garnishment to show disbursement of monies held by the Sheriff	\$5.00	

The increased fee charges are required to offset costs associated with these services.

Many of these increases will exceed five percent (5%) of the amount currently being collected for such Sheriff's fees in Cassia County, Idaho for the types of services indicated.
