Meeting Minutes May 21, 2015

1. Call to order

Chairman Glenn Houthuysen called the meeting to order at 7:29 pm.

2. Statement of compliance

Chairman Houthuysen advised that notice of the meeting was published pursuant to the requirements of the NJ Open Public Meetings Act.

4. Adoption of minutes from the 3-19-15 meeting

The meeting minutes from the March 19, 2015 were reviewed and accepted into the record.

5. Old business

- a. Town Survey Status:
 - Review of the proposals.
 - Keystone Preservation- Intensive Survey, \$18,445.00
 - Barton Ross and Partners \$9,400
 - Wise Preservation \$14,440
 - Discussion proceeded on the merits of each proposal, comprehensive vs. intensive, importance of creating districts and how many districts might be created.
 - Mr. Blinder suggested that we need to review potential homes that might be slated for demolition in the near future and a list should be compiled.
 - Mr. Hynes felt that the commission needed to vote on the proposals in an expedited manner because of the need to identify properties.

- Consensus to vote:
 - Ms. Hawkins moved that we vote on the proposals, Mr. Hynes seconded that motion.
 - A unanimous vote was taken that the Barton Ross proposal should be accepted based on cost and the fact that since they are local (Livingston, NJ) availability would be facilitated.
 - Mr. Hynes questioned that we would need attorney review of the proposal.
- **b.** Review of the meeting with Joe Martin with Chairman Houthuysen and Mr. Blinder along with VLPC actions taken in this meeting.
 - Chairman Houthuysen and Mr. Blinder discussed changing the focus of the ordinance that currently requires homeowner consent with Mr. Martin. (Section 150 15.10)
 - VLPC attorney: The VLPC cannot use the Planning Board attorney.
 - Options are to use the township attorney or find our own attorney.
 - The VLPC agreed to use Michael Gannaio, the township attorney.
 - Mr. Nochimson will contact Mr. Gannaio to make him aware that the VLPC will be in contact and will need to have the Barton and Ross contract reviewed.
 - Change of name to Verona Historic Preservation Commission: In the township ordinance the VLPC is designated as the "Landmarks Preservation Commission."
 - This, along with the consent clause, is an ordinance change.
 - The VLPC email address need to be changed.
 - Storage of documents and paperwork related to the commission.
 - Mr. Martin suggested a secure offsite location with 24 hour access but the VLPC would prefer a local file cabinet with a key.
 - Name Plates
 - Minutes: the VLPC will be able to utilize someone from the township office, preferably the clerk, for meetings of significance.
 - Financial Disclosure Forms: The need for this is a question for Mr. Gannaio. They are basically forms that show there is no potential conflict of interest.
 - Budget Proposal; Chairman Houthuysen submitted a proposal but Mr. Martin indicated that he had some discretionary funds that could even cover the cost of the survey.
 - Mr. Nochimson feels that is would be best to assign money for use by the VLPC as a budget item and replenished at the end of the year.

- Ordinance Change: Section 150 15.10
 - The change that would no longer require homeowner consent for a property to become identified.
- Annin Flag: it appears as if the plans for conversion are going forward with a new developer.
