#### Call to Order:

Municipal Clerk reads notice of Open Public Meetings law.

# Roll Call:

Mayor Kevin Ryan, Deputy Mayor Michael Nochimson; Councilman Bob Manley and Councilman Alex Roman. Township Manager Matthew Cavallo, Township Attorney Brian Aloia and Jennifer Kiernan, Municipal Clerk. Councilman Jay Sniatkowski is absent.

Mayor Ryan leads the Pledge of Allegiance.

# **Approval of Minutes:**

Minutes from the February 16, 2016 meeting are moved for approval by Deputy Mayor Nochimson; seconded by Councilman Roman. Vote: 4 ayes.

<u>Mayor's Report:</u> Mayor Ryan welcomes County Liaison Jay Coltre to the lectern. Mr. Coltre presents the Council with a check in the amount of \$108,738 on behalf of the County for the Community Development Block Grant. He also announces that the two giraffes, Lincoln and Milo have arrived at the Turtle Back Zoo. They are currently quarantined and the exhibit will open to the public in the spring.

He reports he visited the fields this weekend and is happy to see progress. However, he was disturbed that access was still possible to the bleachers, which he commented, are steep and had previously expressed his concern with their safety. He recommended a gate be constructed to prevent access to the bleachers when the field is not in use.

He displays pennants he received as thanks from the 3<sup>rd</sup> graders from Forest Avenue School. He was invited to read to the students for Read Across America Day.

<u>Manager's Report:</u> Matthew Cavallo reports that the VTV bulletin board is malfunctioning and is currently offline. A call has been placed to the vendor as internal troubleshooting has been unsuccessful.

He gives an update on the fields and announces that Freedom Field will be turfed in the late spring.

The library renovation began 10 days ago with demolition. The Children's Reading Room has been relocated to the other side of the library.

Steven Neale is invited to approach the lectern by the Township Manager. He announces the  $2^{nd}$  annual Green Fair will be held on Saturday, May 21 from 11am-4pm in the Civic Center. This year there will be food trucks and live music. He expects over 100 vendors.

Mr. Cavallo reports that he attended a meeting with the County Executive, Joseph DiVincenzo, Jr., Jim Helb and other interested parties. West Orange has proposed a residential development which would abut Howell Drive in Verona. He states that in the 1990's the town made an opinion opposing any project with access to Verona roadways.

# Councilmembers' Reports:

Deputy Mayor Nochimson asks the Town Manager if Freedom Field will be lined for U-12 soccer. Mr. Cavallo responds in the affirmative. He reports that VMAC had a successful meeting with the Board of Education. Juvenile officer Joel Martin was in attendance. Many new ideas were discussed.

He asks about the status of the rock wall for the Community Center. Mr. Cavallo responds that originally the project was quoted at \$35,000 but has increased since then. He will continue to pursue the project as he plans to include the rock wall in the Capital plan this year.

The Deputy Mayor states Bob Williams has contacted him stating his desire to present properties in Verona he feels are of historic value. The Deputy Mayor asks that someone from the Township reach out to him. Mayor Ryan suggests that Mr. Williams' concerns and ideas are best suited to go before the Landmarks Preservation Commission.

Councilman Manley asks Mr. Helb if the new water tank is completed. Mr. Helb responds that the old tank will be taken down to be refurbished while the new tank is relied upon. The old tank will not be painted until the fall months. Mr. Helb reminds Council that this project is fully funded by Passaic Valley Water Commission.

Councilman Manley states he attended the Public Safety meeting with Chief Stern to discuss internet and phone scams targeting the elderly.

Councilman Roman states the Planning Board has found the Steep Slope ordinance to be consistent with the Master Plan and the ordinance will be on the next regular meeting's agenda for second reading and public hearing.

**WHEREAS**, poison centers across the country focus the public's attention on identifying poisoning hazards at home as well as learning ways to prevent poisoning emergencies; and

**WHEREAS**, unintentional poisoning is the leading cause of unintentional injury death in New Jersey; and

**WHEREAS**, approximately half of all reported poison exposures involve children five (5) years old and younger; and

WHEREAS, the majority of poisoning deaths occur in adults aged 20 to 59; and

**WHEREAS**, every poisoning is preventable! From the youngest to the oldest, all people and even pets are at risk; and

**WHEREAS**, poison experts urge parents and caregivers to keep "single-load liquid laundry packets" out of sight and reach of young children. These products can cause serious harm if ingested; and

WHEREAS, consumers must be aware that e-cigarette devices, hookah pipes and liquid nicotine may contain very high doses of nicotine in enticing colors, aromas, and flavors; increasing the likelihood that small children and pets will be drawn to them. These products pose serious risk of poisoning; and

**WHEREAS**, the New Jersey Poison Information and Education System (NJPIES), a division of the Department of Emergency Medicine of the New Jersey Medical School of Rutgers, The State University of New Jersey, provides free, expert medical advice, drug information, and poison prevention education to NJ residents through the 800-222-1222 Poison Help Hotline; and

**WHEREAS**, all services are provided free of charge, confidential, multilingual and available 24 hours a day, 7 days a week, 365 days a year even during bouts of Mother Nature; and

WHEREAS, poison centers save time and money by managing most cases at home, not requiring a visit to an emergency room; and

**WHEREAS**, NJ Poison Experts encourage all residents to program the Poison Help Line 800-222-1222 into home, office, and cell phones because a rapid response can make a difference in preventing serious injury and saving lives; and

WHEREAS, NJPIES is involved with the state's efforts in homeland defense, counterterrorism, emergency preparedness and response, and bio surveillance, and surveillance for clusters of poisonings and their sources (products, food and beverages, chemicals in the workplace and at home, environmental toxins, drugs and medicine, and animal and insect bites and stings; and

**WHEREAS**, the use of poison center services saves residents both time and money. Most cases are managed in the convenience of the caller's home, requiring no hospital visit; and
