Minutes of a Regular Meeting of the Verona Township Council on Monday, April 17, 2017 beginning at 6:30 P.M. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law.

Mayor Ryan leads the Pledge of Allegiance.

Mayor's Report:

Mayor Ryan reads a proclamation for Distracted Driver Awareness Month. He then reads a proclamation for Arbor Day and reminds the public that the Environmental Commission is holding their sapling disbursement program on April 22nd. Mayor Ryan then calls Kathy Mortara and Linnea Mathers from the Woman's Club of Verona to the lectern and presents them with a proclamation recognizing April as Child Abuse Prevention Month.

Mayor Ryan invites Essex County liaison, Julius Coltre to the lectern. Mr. Coltre states a meeting took place between the County Engineer with the Township Manager and Township Engineer to discuss traffic issues in town. This discussion will be ongoing and a plan formulated in the future. The County will host a Small Business Program at McCloone's Boathouse on Thursday, April 27, 2017. Hazardous Household Waste Drop Off will be held on May 6, 2017 at 125 Fairview Avenue.

Mayor Ryan states the Township has benefited from \$7.5 million in Community Development Block Grants (CDBG) since 1979. He has written a letter to Congressman Frelinghuysen in regards to the President's desire to eliminate the CDBG in 2018. The Mayor states he sent letters to US Senator Menendez and US Senator Booker as well.

The Mayor received a letter from the State regarding initiating Safe Streets for cyclists. He passes the letter on to the Township Manager.

Mayor Ryan also states the Verona Park Conservancy held a Clean Up Day on April 7th which was very successful. He reminds the public that the Conservancy is looking for volunteers.

Manager's Report:

The 2017 Municipal Budget Documents is scheduled to be adopted at Monday's meeting.

We have received our approval from the Division of Local Government Services to adopt the budget. The Division required a minor change to account for the Pool Utility statutory payments. This change does not require delay of the budget adoption.

There are two ordinances with regard to the purchase of the 56 Grove Avenue property (currently Congregation Beth Ahm). The Township plans to purchase the property for use of Municipal Services. There is Council Discussion regarding the acquisition of the property and alternative ideas for use.

The Verona Environmental Commission in cooperation with the Cedar Grove Environmental Commission and the Essex County Environmental Center conducted a cleanup of the West Essex Trail on Sunday, April 2. About 70 volunteers worked all morning long removing over six (6) truck loads of trash, tires, metal fencing and pipes, cinder blocks, lawn chairs, metal drums, cardboard, bottles, cans, broken glass, car batteries and even school bus seats.

The Verona Environmental Commission will be distributing free Tree Seedlings at the Grove Park on Saturday, April 22nd from 8:00 a.m. to 12:00 noon.

The Township Manager reports that he, Jim Helb and Chief Stern met with the County Executive, County Engineer and County Counsel regarding several traffic concerns in town including additional crosswalks, signage, and traffic signals. The meetings was successful. The Township is preparing a list of additional signage we are looking for along the Lakeside Avenue corridor including Speed Limit signage, reduced speed ahead, crosswalks markers, crosswalk ahead, etc. The County install the signage.

The Township will be renewing our Traffic Light Warrant for Personnette Avenue and Fairview Avenue. The County will be marking the crosswalk on Fairview Avenue at Linden Avenue. The County will be marking the crosswalk on Fairview Avenue at Sampson Drive once the sidewalks are installation on the west side of the roadway. This project will be awarded at tonight's Council meeting. County Counsel recommended that the Township work with NJ Transit & DeCamp to coordinate designated DeCamp Bus Stops town-wide and establish them by Ordinance.

At the next meeting there will be an ordinance to make several modifications to the Vehicles and Traffic section of the Township code to address parking concerns, additional stop signs and flow of traffic. This includes Personnette Avneue. The Ordinance with regard to traffic flow on Personnette Avenue that was tabled at the last meeting will remain tabled.

In response to concerns from the residents of Dodd Terrace at the Planning Board hearings from the High School field construction and increased parking at the high school sporting events, Chief Stern and Jennifer Kiernan on my behalf met with the residents of Dodd Terrace to discuss options going forward. A No-Right-Turn restriction is being planned and implemented from Sampson Drive onto Dodd Terrace to avoid traffic going East on Dodd Terrace from Sampson.

Future items that will be presented to the governing body include no parking extended 75 feet on Fairview Avenue, across from Sampson Road to accommodate line of sight for the intersection. A No Left Turn from the loop of VHS onto Fairview will be implemented. One handicap parking spot on the west side of South Prospect will be removed and 2 hour parking implemented. A stop sign will be placed at the bottom of Chestnut Road where it meets Oakridge Road. Claremont Avenue will be designated as a through street with stop signs placed at all intersections and no left turns out of streets that run into Lakeside Avenue.

A resolution is on tonight's agenda in support of Assemblywoman Holly Shepisi's two bills currently in the Assembly with regard to Affordable Housing legislation. Please refer to the articles emails on April 12^{th} .

PSE&G will be performing a large gas main replacement program in the area of FN Brown school starting tomorrow. Upgrades to gas lines and replacement of 100 year old pipes will be performed. This program is spearheaded by the Board of Utilities and allows for homeowners to put natural gas generators in their homes. Residents will be notified ahead of time by placement of door hangers.

Mr. Cavallo reports the Township has been ordered by the Board of Taxation to perform a revaluation of the Township in 2019. An RFP will be released within two weeks and awarded sometime in June with inspections occurring in late August, early September. The last inspection has to be completed and filed with the Department of Taxation by October 1, 2018. Mr. Cavallo explains that in most municipalities that go through mandated revaluations, in terms of increases and decreases, one-third of the properties goes up, one-third goes down, one-third stays the same.

Councilmembers' Reports:

Deputy Mayor Nochimson requests the status of open fields this spring. The Township Manager states once all sports programs have been finalized, open field times will be released.

Councilman Sniatkowski has no report this evening.

Councilman Manley commends Rich Williamson of the VBSL, their coaches and staff on a great parade. He thanks the Police Department and DPW for creating a safe route.

Councilman Roman has no report this evening.

RESOLUTION URGING THE LEGISLATURE TO REDUCE LOCAL AFFORDABLE HOUSING BURDENS AND PROVIDE DEFINED RULES AND RELIEF IN PROVIDING THEREOF

WHEREAS, New Jersey municipalities do not have the resources to provide court mandated housing to comply with the Mount Laurel doctrine without proper funding; and

WHEREAS, lawsuits increase housing four-fold through court mandates and without an affirmative defense municipalities can do nothing to stop growth and sprawl, costing millions of dollars outside of local budgets; and

WHEREAS, property taxes must be raised exponentially to pay the costs associated with court mandates and, therefore, population, further overburdening taxpayers; and

WHEREAS, the cumulative impact of years of unfunded court mandates has left many municipalities with serious needs and burdensome property taxes; and

WHEREAS, expected state population growth of 0.3 percent does not provide sufficient demand to justify court-mandated 30 percent housing supply increase; further congesting our state; and

WHEREAS, New Jersey is already the most densely populated state in the country with 1,195 persons per square mile; and

WHEREAS, the quality of life and public welfare in this municipality will be reduced, negatively impacting infrastructure, water and sewer capacities; school class sizes and school services; municipal services such as volunteer and staffed ambulatory services and fire departments, police departments, public transportation and traffic; and

WHEREAS, the lack of affordable housing and rentals is not due to a lack of units, rather it stems from residents paying property taxes that are unaffordable and increasing by roughly \$700 million annually; and

WHEREAS, the state of New Jersey should relieve the burden of unfunded court mandates and provide statewide parity and predictability in regard to municipal affordable housing obligations; and

WHEREAS, the Assembly is urged to pass Assembly Bill No. 4666 imposing an end-of-year moratorium on all affordable housing litigation; and Assembly Bill No. 4667 establishing the "Affordable Housing Obligation Study Commission" to assist in finding solutions to the affordable housing crisis foisted upon municipalities by the end of the year; and

WHEREAS, it is the responsibility of the state and the legislature to assist municipalities; and

WHEREAS, the time has come to reasonably address affordable housing needs in New Jersey to preserve the integrity of the state and its quality of life.

NOW, THEREFORE BE IT RESOLVED that the Mayor and Council of the Township of Verona, in the County of Essex, New Jersey urges the State and the legislature to aid municipalities over-burdened by court-mandated affordable housing; and be it further

BE IT FURTHER RESOLVED that we enthusiastically must reach a solution to affordable housing in New Jersey; and be it finally
