MINUTES

Chair of the Infrastructure Committee Keith A. McLiverty called the joint special meeting to order at 6:00 p.m. All rose and pledged allegiance to the flag.

PUBLIC PORTION

Mr. McLiverty asked three times if anyone wished to address the committees. Hearing no requests...

A MOTION was made by Mr. Bell with a second by Mr. Walsh to close the public portion. **Motion carried**.

ROOSEVELT DIRVE WASTEWATER PUMP STATION UPGRADE - PRE-AWARD PROJECT REVIEW - DISCUSSION/POSSIBLE ACTION (EXECUTIVE SESSION IF NEEDED)

Mr. Tedeschi told the committee members that there was a mandatory pre-bid conference held on March 12, 2018 at Derby City Hall. Seven contractors attended the mandatory pre-bid:

- 1. L. Holzner Electric Company
- 2. Carlin Contracting
- 3. Delray Contracting
- 4. True Blue Environmental

- 5. Blake Equipment Cornell Pumps
- 6. Baltazar Contractors
- 7. CH Nickerson

Addendum #1, which focused on the questions and answers raised during the pre-bid conference, was issued on March 28, 2018. Two bids were received for the Roosevelt Drive Wastewater Pumping Station Upgrades Project:

- L. Holzner Electric Company, Bridgeport, CT \$7,427,000.00
- Baltazar Contractors, Ludlow, MA \$8,499,025.50

Mr. Tedeschi explained that both bids were reviewed for errors and due diligence. He said that the low bidder, L. Holzner Electric Company, has checked out very favorably. He informed the committee members that a pre-award meeting was held last week with L. Holzner Electric Company at Derby City Hall. Mr. Tedeschi said they wanted to make sure that L. Holzner totally understood the scope of the project, the approach, costs, etc. He informed the committee members that he is assured that L. Holzner Electric Company has a really good job understanding of the project and they are ready to move forward.

Mr. Tedeschi told the committee members that he also placed calls to the contractors that attended the mandatory pre-bid but did not submit a bid for the project. Some of their comments were:

- Accessibility to the site is a nightmare too risky and all eyes are on the site.
- Location issue is too hard to build on site
- The City in the past has had similar projects that they bid out and the contractors but time and effort into preparing a bid and the project for one reason or another never came to fruition. They found it to be a total waste of their money.

Mr. Tedeschi said L. Holzner Electric Company is based in Bridgeport, CT. They are three to four years into this business and they work with United Concrete who will build the pump station. He said they just did a boat launch in Norwalk and they have done a smaller pump station. Mr. McLiverty asked how many pump stations have they built? Mr. Tedeschi said he didn't know the number but it's at least one and possibly two or three. He noted that United Concrete is building the pump station so the site work is really the main job. He said if this was a "soup to nuts" bid he feels that we would have at least 10 to 12 subcontractors to deal with. Having it done pre-fab is much easier.

Mr. Miani brought up the discussion of pre-fab vs. poured. He said we were told during one discussion that it should be a 50% reduction in cost savings. We've gone from \$8 million to \$4 million and now back to \$8 million how did we manage to get back to this number. Mr. Tedeschi said the original estimate was \$7.46 million at a different site in September 2016. This was revisited because DEEP wants it where it is scheduled to go to now.

Mr. Walsh said that both engineers gave us the lower fee to go with savings from Emmett Avenue. Mr. Tedeschi said they incorporated the recommendations from Westcott and Mapes. Mr. Walsh said the committees acted on the expertise of the engineers. Mr. Tedeschi said their design fee is less than 4% of the project. Mr. McLiverty noted that we have paid close to \$400,000. Mr. Miani said the original estimate was \$7.4 million and now the bid comes in at \$7.4 million – he finds this very ironic. Mr. McLiverty said the \$7.4 million was across the street. Mr. Miani said if we went across the street we would have to dig and buy property. Mr. Walsh noted that the figure for the Bond Referendum was published numbers and he said at least one firm said that's where they got their number to bid.

Mr. Miani questioned whether the committees had a meeting with Westcott and Mapes. Mr. Walsh said they had a meeting last week. He said L. Holzner Electric Company came to the second meeting very well prepared. He said he's not an engineer and he has to rely on our engineers. They have also recommended L. Holzner Electric Company for the project.

Mr. Tedeschi reviewed the Timeline/Budget Summary for the Referendum Capital Projects. He explained the summary included all the referendum projects, including the two projects that are on hold:

<u>WPCF Upgrades – Solids Dewatering</u> – This was put out to bid in 2015 and the State said to put it on hold.

<u>WPCF Upgrades – Phase 1 Upgrades</u> – Mr. Tedeschi said there is a component at the Treatment Plant, which has an \$8.9 million budget that includes electrical upgrades, (inaudible), pump station, screens, and work on the digester. If we eliminate the (inaudible) digester system that brings (inaudible) on budget and that would put us back on tract.

Mr. Walsh asked Mr. Iacuone from the Water Pollution Control Treatment Plant if he would be comfortable with this being taken out. Mr. lacuone said although he would like the digester he would rather the Plant. Mr. Walsh said the contract has been awarded for the study but we have to keep in mind that it probably takes 18 months for anything to happen. Mr. lacuone said the electrical part of the plant needs to be done. The screenings have to say in (have to take the solids out.) He said the belt press, solids are part of the debacle with the State. Mr. McLiverty said the hesitation of taking funds from one of these projects that are on hold is when that time comes and we need to do that we won't have the money. Mr. Walsh said we will have the money to do the electrical. Mr. McLiverty said that's in the referendum to be done. He said there is a legislative action that we will be required to change how we're going to do this through the bond proceeds - a change in the scope. He said he gets very hesitant with taking savings from something that far down the road that we have to do and now we may not be able to. Mr. Curtis asked what the savings is by dropping Phase 1 pump (inaudible) we're only going to drop a portion of it – we're not dropping the whole plan. He said if its \$8.9 what part of that is the digester? Mr. Tedeschi said the digester

as part of the referendum number was \$1.3 million. He said we're not taking all of that out – we only took it out to make it whole and that would be the least impact.

A MOTION was made by Mr. Bell with a second by Mr. Curtis to go into Executive Session at 6:28 p.m. **Motion carried**.

Regular Session resumed at 7:07 p.m.

A MOTION was made by Mr. Miani with a second by Ms. Pertoso to modify the scope of work for the bond referendum per the attached handout (Referendum Capital Projects – Timeline/Budget Summary – Updated April 2018) and award the Roosevelt Drive Wastewater Pump Station Upgrade to L. Holzner Electric Co. pending Bond Counsel review and approval.

DISCUSSION ON MOTION

Mr. McLiverty said he hopes they keep their Change Orders in check. Mr. Tedeschi said they have been advised of that.
