Parks & Recreation Director's Report: Mr. O'Connell reported that the Pop Warner season is over. They did have lower participation numbers than last year. That is apparently a trend as he is also seeing lower numbers in the basketball registration. He held basketball registration at the Derby Veteran's Community Center and response was disappointing. Grades 1 & 2 instructional has 23 participants. Grades 3 & 4 was able to field two teams and will again be playing with Ansonia. Grades 5 & 6 and grades 7 & 8 do not yet have enough participants to form teams. One reason that may explain the lower numbers is that many of the youth are already involved with the Boys/Girls Club in Shelton.

At the Derby Veteran's Community Center swim lessons are very popular. The open swim is not well attended. Rentals are still being booked for gym time. Mr. O'Connell is seeing a downturn in patrons and it may be impart due to the neighborhood influences.

Mr. O'Connell is seeking estimates for the fire alarm at the Derby Veteran's Community Center building.

High School Athletic Director's Report: Mr. Bradshaw reported that he is working on the spring schedule but with the uncertainty of field availability it is quite challenging.

Cheerleading had their homecoming week. Senior night was held. Cross country did very well again. Football holds a record for rushing this year.
