Sec. 14. Dual office-holding, etc. [Approved at referendum 11-4-2003, effective 12-3-2005] No officer of said city shall be at the same time a member of the Board of Aldermen. Neither the Mayor, Street Commissioner, Police Commissioners, Fire Commissioner nor any other officer of said city, either elected or appointed, including members of the Board of Aldermen, members of the Board of Apportionment, members of the Finance Committee and members of the Board of Education, shall directly or indirectly furnish any materials to said city, or be directly or indirectly employed to do any work for said city except his official duty. The provisions of this section may be waived by a unanimous vote of the Board of Aldermen.
