- 1. Purpose of the Meeting to review dissolution process and kick-off study with Committee, Consultant, and NYS Department of State.
- 2. Project Objective The primary objective of this project is to develop a detailed Dissolution Study with a recommended Dissolution Plan and Alternatives to Dissolution which answers questions that Village of Richville and Town of DeKalb residents have about the dissolution process, impacts of dissolution, and how dissolving would affect residents and local governments. The final report will provide the Village of Richville with a report that includes the following elements: Executive Summary, Introduction, Population Trends, Local Government Tax Rates, Assets & Real Property Information, Operating Budget Summary, Fund Balances & Outstanding Debt, Municipal Program Summaries, and Legal Issue & Impediments. This information will be utilized to determine: 1) Potential Financial Savings; 2) Management Improvements; 3) Service Delivery Changes resulting from a local government re-organization; and 4) Alternatives to Dissolution. These items will be summarized in the Recommendations section of the Plan.
