- 1. The committee reviewed the draft Dissolution Implementation Plan
 - a. Clarification in the plan was requested to document that the hamlet will continue to be called Harrisville after dissolution.
 - b. Addition of a task for updating the Village's website into a Town municipal website was identified as a priority; costs will be adjusted accordingly.
 - c. Water Meters G. Williams reported that he spoke with Tom Voss at NYSDEC and the Village will not have to install water meters. This is not consistent with prior discussions with NYSDEC and additional clarification will be requested to share with the Committee. The Committee agreed to keep this in the Implementation Plan unless documentation can be provided by G. Williams or the NYSDEC that shows the Village will not be required to install meters. C. Tuttle suggested that the funding available through NYSDOS be utilized to install master meters and develop a conservation program. Since the Committee recommended that billing practices not change, and therefore not become meter based, then individual meters may not be necessary to achieve an acceptable Water Conservation Program. However, if additional meters are desired, other funding sources could be pursued such as the NYSDOS MRF Grant, NYSDOS LGE Implementation Grants, and/or NYSEFC DWSRF, etc. UPDATE 11/22/17: Tom Voss from NYSDEC responded to C. Tuttle's email that the Village's water withdrawal permit does require service metering and the special condition in the permit cannot be removed.
 - d. Section I.6 will be updated to reflect the way that Zoning/Code Enforcement is addressed.
 - e. Clarification was provided that the Village could utilize existing fund balance to the benefit of Village taxpayers by doing water system improvement projects, creating a dedicated reserve for a water tank, etc.
 - f. The Local Law table will be reviewed to confirm that all laws are listed (specifically confirm zoning).
 - g. Clarification was provided that Village local laws will remain in effect for two years after the effective date of dissolution.
 - h. Village board meeting will be on December 11, 2017 at 7:00 p.m. and the Committee will be presenting the final Plan. January 8th is the Village's next regularly scheduled board meeting.
