Date: September 8, 2014

You have asked me whether a Commissioner could meet with the owner of Standard Parking regarding the CM's written recommendation in Agenda Item C-5. The owner of Standard Parking has made that request, and the Commissioner wishes to know if it is permissible. The answer is yes. The Cone of Silence terminates when the CM's written recommendation to the Commission is provided to the City Clerk (i.e. placed on the agenda). Moreover, communications between a Commissioner and a potential vendor is expressly exempted from the Cone of Silence under section 2-1059(3)(b)(15) of the City Code. Finally, the potential vendor (which would include its principal) should register as a lobbyist before meeting with the Commissioner (this is based on the interpretation by the County Ethics Commission as to the County lobbyist regulations).
