Will,

I have conferred by email with outside counsel (Joe Jimenez from Stearns Weaver), who was very helpful, and have considered the matter. Section 105-23 of the City Code incorporates the Florida Building Code. Accordingly, as long as the Building Official does not object, I am comfortable with your officers citing section 105-23 along with the applicable incorporated provision of the Florida Building Code for non-technical matters (such as doing work without a permit). The Building Official or a building inspector should be consulted if Code Enforcement would like to cite any technical requirements of the Florida Building Code, however, and such officer should be available to testify before the Code Enforcement Board or hearing officer if a technical interpretation of the Florida Building Code is required.
