RESOLUTION AUTHORIZING THE RETENTION OF HANNIG CONSTRUCTION,  
INC. TO PROVIDE PRE-CONSTRUCTION MANAGEMENT SERVICES FOR THE  
COMMUNITY POOL PROJECT

WHEREAS, the City of Marshall is in the process of initiating bidding procedures on the new City of Marshall pool; and

WHEREAS, it has been determined by the City of Marshall that there are several vendors who are willing to donate their services as an in kind donation for the construction of the pool; and

WHEREAS, it is necessary to have more separation of services in the bid specs; and

WHEREAS, it has been determined that the employment of Hannig Construction, Inc. to assist Burbach Aquatics in preparing the construction bid documents would be in the city's best interest; and

WHEREAS, Hannig Construction, Inc. has offered to provide these services on a time and material basis in accordance with the attached Exhibit A.

NOW THEREFORE IT IS HEREBY RESOLVED that the City of Marshall hereby agrees to retain Hannig Construction, Inc. to provide pre-construction management services to the City of Marshall in regard to assisting Burbach Aquatics on the detailed scope of work all in accordance with Exhibit A, attached hereto.

Hannig Construction, Inc. shall therefore be retained for said pre-construction professional services on a time and material basis not to exceed \$25,000.00 in accordance with the terms of the attached Exhibit A.

The Mayor of the City of Marshall is hereby authorized to execute the attached proposal retaining Hannig Construction, Inc. in an amount not to exceed \$25,000.00.


