Present: Mayor Julie Maas-Kusske, Councilmembers Dominic Broda, Caitlin Cahill, Mike DeLuca, and John Fay. Also Present: City Administrator Robert Schoen and Assistant to the City Administrator Nicole Kathman.

Councilmembers discussed whether the one-sided parking should apply to the entire City or only certain streets. The City Council directed City Staff to evaluate options for streets to make one-sided parking. It was determined that staff will present recommendations and a cost estimate for signage back to a future City Council Workshop.

City Administrator Schoen shared that Meeks Appraisal would be appraising 6 properties for the Special Assessment data. Schoen stated he anticipated that the public hearing for the special assessments would be held in October.

TRAFFIC--

Includes violations of the road and driving laws.

PART III--

Lost and Found: Includes lost and found persons, animals, and property, and stalled and abandoned vehicles.

PART IV--

Casualties: Includes all motor vehicle accidents, boating, and snowmobile; public home occupational accidents, fires, suicides, sudden deaths, burning permits, and burning violations.

PART V--

Miscellaneous Public: Includes open doors, gun permit applications, suspicious activities, animal complaints, motorist assists, alarm calls, parking complaints, house checks, driving complaints, civil matters, family disputes, department assists.

The balance of the report shows the total number of incidents handled, miles driven and how the Public Safety Department received calls. If anyone should desire more detailed statistical data, please contact my office.

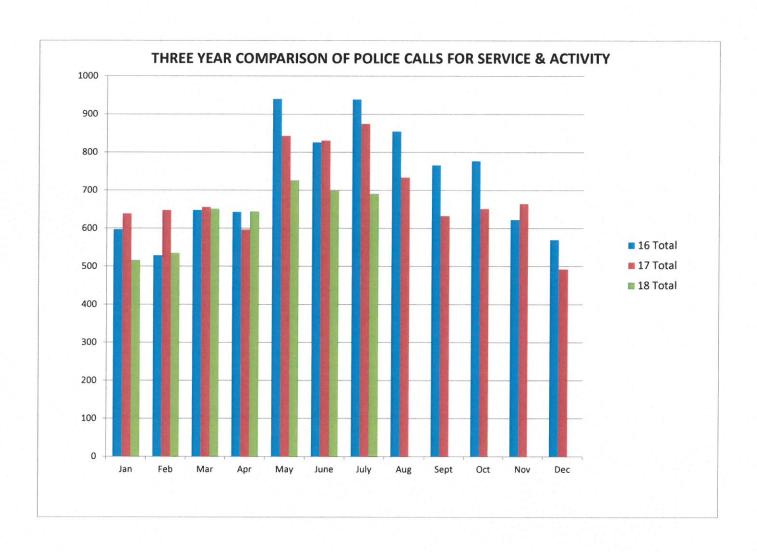

WEST HENNEPIN PUBLIC SAFETY July 2018 Activity Report

Year to Date Activity Report

At the end of July 31, 2018 West Hennepin Public Safety (WHPS) handled a year to date total of 4,463 incident complaints. 2,356 In Independence and 1,749 in Maple Plain. For the month of July, 355 incidents occurred in Independence and 291 incidents were in Maple Plain.

Recent Highlighted Cases:

Drunk Problem

STORM WATER AGREEMENT

This Agreement is entered into between Marsh Land Properties, LLC, a Minnesota limited liability company ("Marsh Land") and the City of Maple Plain, a Minnesota municipal corporation ("City").

RECITALS

- 1) The City has adopted a storm water utility charge pursuant to ordinance number 254, code section 50.02 for all property within the City.
- 2) Marsh Land owns property within the City zoned industrial which property has been charged at the rate of \$2,844.72 per year for storm water charges; that the legal description of the property owned by Marsh Land is:

Outlot A, Maple Plain Industrial Park 4th Edition ("Subject Property")

- 3) Marsh Land has not paid the annual storm water charge for 6 years currently owing in excess of \$16,000; that Subject Property is now in foreclosure for failure to pay these storm water charges with taxes.
- 4) That Subject Property is unique because it receives all or most of the storm water from the Maple Plain Industrial Park and for this reason the City is willing to negotiate the storm water rate with Marsh Land.

NOW, THEREFORE, the parties hereto agree as follows:

- 1) Marsh Land shall pay the City \$1,872 in full satisfaction of the outstanding storm water fees owed to the City.
- 2) Upon receipt of payment, the City shall advise the County Auditor of the settlement and take steps necessary to remove Subject Property from the foreclosure process.
- 3) Commencing in 2014, Marsh Land agrees to pay \$312 per year as and for the storm water charges for Subject Property.
