TOWN OF LANTANA REGULAR MEETING MINUTES January 23, 2017

1. ROLL CALL:

<u>Mayor Stewart</u> called the regular meeting to order at 7:00 p.m. and <u>Mrs. Dritz</u> called the roll. There was a moment of silent prayer followed by the Pledge of Allegiance to the flag. 2. APPROVAL OF MINUTES:

Councilmember Balfour made a motion to approve the regular meeting minutes of January 9, 2016.

Motion passed 5-0.

3. AGENDA APPROVAL:

<u>Vice Mayor Aridas</u> made a motion to approve the agenda as submitted.

Councilmember Moorhouse seconded the motion.

Motion passed 5-0.

4. STAFF AND COMMITTEE REPORTS:

a. Council Reports

<u>Vice Mayor Aridas</u> Thanked Town Staff for a great Movie Night at the Beach.

<u>Mayor Stewart</u> stated that Mr. Burke, Principal from Lantana Middle School, will be visited by a middle school from South Carolina so that they can take notes on how our Middle School continues to be so successful.

b. Town Manager Report

Town Manager Manzo introduced the Information Technology Manager, William Parker, who gave a brief overview of the brand new Town website.

5. ORDINANCES AND RESOLUTIONS:

a. Consideration of Ordinance O-01-2017 providing additional parking regulations for parking on the street in the R1-A zoning district.

<u>Mayor Stewart</u> introduced and explained this item on the agenda. <u>Town Attorney Lohman</u> read the resolution title:

ORDINANCE NO. O-01-2017

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF LANTANA, FLORIDA, AMENDING ARTICLE I. OF CHAPTER 19. TRAFFIC AND MOTOR VEHICLES. AT SEC. 19-4 PARKING PROHIBITED; EXEMPTIONS. BY ADOPTING AN ENTIRELY NEW SUBSECTION (20) TO PROVIDE FOR ADDITIONAL PARKING REGULATIONS FOR PARKING ON THE STREET IN THE R1-A ZONING DISTRICT; FURTHER AMENDING SECTION 19.4-4. TOW-AWAY ZONES. IN ORDER TO PROVIDE INTERNAL CONSISTENCY AND CLARITY; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

<u>Mayor Stewart</u> asked for Council disclosures. <u>Vice Mayor Aridas</u> and <u>Councilmember Balfour</u> both disclosed they spoke with the Town Manager. <u>Mayor Stewart</u> disclosed he spoke with the Town Manager, some Island residents, and his wife, Pam. Dave Arm, Greater Lantana Chamber of Commerce, gave an overview of the request.

Dave Arm answered questions from Council.

<u>Councilmember Moorhouse</u> made a motion to approve the Greater Lantana Chamber of Commerce's request to waive the Lantana Recreation Center rental fees for the Greater Lantana Chamber of Commerce Annual Lantana Fishing Derby event and weekly preparations, with the condition that the Lantana Chamber of Commerce submit the required paperwork to the Plan Review Committee for approval.
